1. At the option and expense of the adopter this Dog will be taken to a licensed veterinarian for a thorough health exam within 48 hours from time of adoption. Known existing health problems at time of adoption: _____

NEITHER WILL IT BE GIVEN OR SOLD TO ANOTHER PARTY. I/We understand WIN Rescue reserves the right to reclaim the Dog pending its re-placement in another home approved by WIN, and that if this is necessary after the first 30 days, all adoption fees are forfeited in the interest of finding the Dog a good, permanent home. _____
3. This Dog has been Spayed/Neutered. I understand that a spayed/neutered dog cannot give birth or father puppies. _____
4. I/We agree that the information contained in the Application for Adoption is still true and correct and that any breach of the application shall constitute a breach of the Agreement. _____
